



**PUBLIC MEETING NOTICE**  
**Proposed Roadway Improvements**  
**SH 99: SH 146 to Fisher Road**  
**Harris and Chambers Counties, Texas**

The Texas Department of Transportation (TxDOT) will conduct an open house public meeting to discuss proposed improvements to SH 99 from SH 146 to Fisher Road, in Harris and Chambers Counties, Texas.

The purpose of the meeting is to discuss the social, economic, and environmental effects of the proposed improvements. The proposed improvements include construction of additional travel lanes, overpasses, and interchanges at some existing roads. Two-lane frontage roads are proposed to be constructed parallel to the majority of the travel lanes. A replacement bridge over Goose Lake and an additional bridge over Cedar Bayou would also be constructed. Travel on the frontage roads, bridges, and some overpasses would be free (non-tolled). In addition to the non-tolled improvements, a 4-lane tollway with overpasses at intersecting streets is proposed.

This roadway is a portion of the roadway known as Grand Parkway, Segment I-2, that extends from SH 225 to IH 10E. The proposed improvements would require the acquisition of approximately 46 acres of right-of-way (ROW) from SH 146 to FM 1405. The typical ROW width varies from 300 to 400 feet. The proposed tollway includes the installation of overhead gantries for electronic toll collection. Travel on the frontage roads and bridges over Goose Lake and Cedar Bayou would not be tolled. Public comments regarding the proposed roadway improvements would be solicited at this meeting.

All interested citizens are invited to attend, to express their views, and discuss the project with TxDOT representatives. Those interested in attending who have special communication or accommodation needs are encouraged to contact the TxDOT District Public Information Officer at (713) 802-5072 at least two working days prior to the date of the meeting. TxDOT offices are open Monday through Friday, from 8:00 a.m. to 5:00 p.m., excluding state holidays. The public meeting will be conducted in English. Requests for language interpreters or other special communication needs should also be made at least two days prior to the date of the public meeting. TxDOT will make every reasonable effort to accommodate these needs.
